

BUCKS COUNTY NATURAL GAS PROJECT

Newtown Borough and Newtown Township

PROJECT OVERVIEW

PECO is investing \$1.7 million in Newtown Borough and a small portion of Newtown Township as part of the company's proactive efforts to upgrade the local natural gas distribution system.


The project is critical to meeting the growing need and demand for safe, reliable, and affordable natural gas for our customers in Newtown Borough, Newtown Township, and across Bucks County.

This investment will allow homes, businesses, and communities to convert to natural gas service. This project will also provide more natural gas into the area where it would otherwise be constrained, potentially causing reliability issues during the coldest days of the year for existing customers.

PROJECT DETAILS AND SCHEDULE

This project involves replacing existing natural gas main and service lines with new plastic pipe, which enhances safety, is more durable, improves service, and reduces methane emissions.

The majority of the construction work will occur in Newtown Borough on State Street from Penn Street to the Borough boundary. A small portion of the work will extend on State Street in Newtown Township.




Construction is scheduled to begin at Centre and State Streets in July 2025. The anticipated completion date is November 2025.

This work will require detour and lane closures on State Street on a block by block basis to minimize disruption during hours of construction. Access will only be restricted to blocks being actively worked that day.

A detour on State Street will be in place Monday through Friday from 9 a.m. to 3 p.m., with lane closures. Access to all businesses will be maintained for the entirety of the project. Emergency access, mail and package delivery, trash removal, and school bus transportation will be maintained.

Dear Customer:

We are contacting you about an upcoming project occurring in Newtown Borough and a small portion of Newtown Township that will enhance the local natural gas infrastructure. This \$1.7 million infrastructure investment is critical to meeting the growing need and demand for safe, reliable, and affordable natural gas for our customers in Newtown Borough, Newtown Township, and across Bucks County.

About the Project:

- We will be replacing the existing natural gas main and service lines with new plastic pipe, which is more durable, enhances safety, and improves service reliability.
- The majority of the construction work will occur in Newtown Borough on State Street from Penn Street to the Borough boundary. A small portion of the work will extend on State Street in Newtown Township.
- Work is expected to begin at Centre and State Streets on July 21, 2025,
- The project is expected to be completed in November 2025.
- This work will require detour and lane closures on State Street on a block-by-block basis to minimize disruption during hours of construction. Access will only be restricted to blocks being actively worked that day.
 - o A detour on State Street will be in place Monday through Friday from 9 a.m. to 3 p.m., with lane closures.
- Access to all businesses will be maintained for the entirety of the project. Emergency access, mail and package delivery, trash removal, and school bus transportation will be maintained.
- This work will be performed by General Asphalt Paving Co of Philadelphia, a qualified PECO contractor. If you have any questions or to schedule an appointment, please contact Joe Meehan of General Asphalt Paving at 215-677-2626. Most of the work will be performed outdoors, but to safely connect your property to the new natural gas main, PECO or a PECO contractor will need to turn off natural gas service and then enter your property to relight your appliances after the connection. We will need access to the natural gas appliances or equipment in your home so we can perform this work and later that day to restore service and relight any appliances. At this time, we will also be relocating any indoor natural gas meters to the exterior of the building to a location that is aboveground and is as close as practical to the existing indoor location.

This relocation work is necessary for the safety of our employees, contractors, customers, and communities and is mandated by the Pennsylvania Public Utility Commission.

Prior to work beginning, customers should mark any customer owned facilities present on the property. Examples of customer owned facilities include, but are not limited to, water services, sewer laterals, septic tanks, underground cable, drainage pipe, security lines, private lighting, dog fences, and sprinkler systems.
